Ministerial Regulation No. 27 (B.E.2546)
issued under the Immigration Act B.E.2525

Effective: 26 August 2003

Relevant Authority: Ministry of Interior

The significant details of this Ministerial Regulation are as follows:

The rates of the government fees prescribed under No. 1 of the existing Ministerial Regulation (B.E.2523) as amended by the Ministerial Regulation No. 26 (B.E.2543) issued under the Immigration Act B.E.2522 (A.D.1979) shall be cancelled and substituted by the following new rates.
